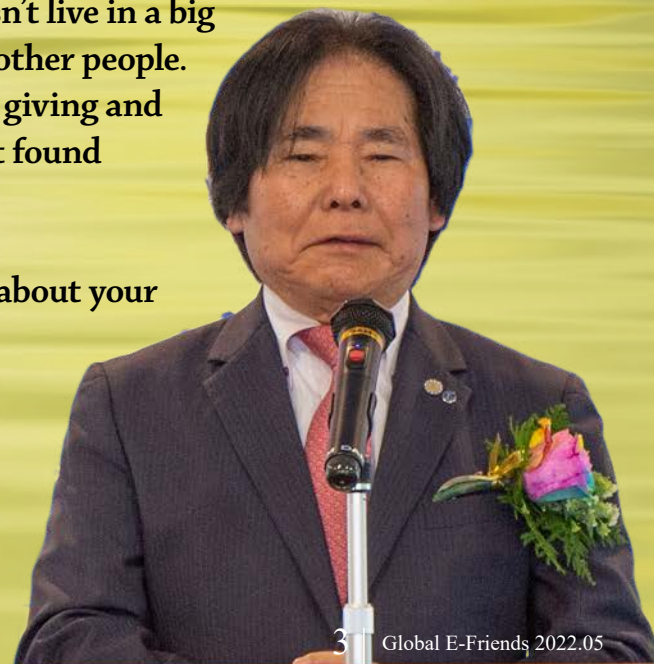

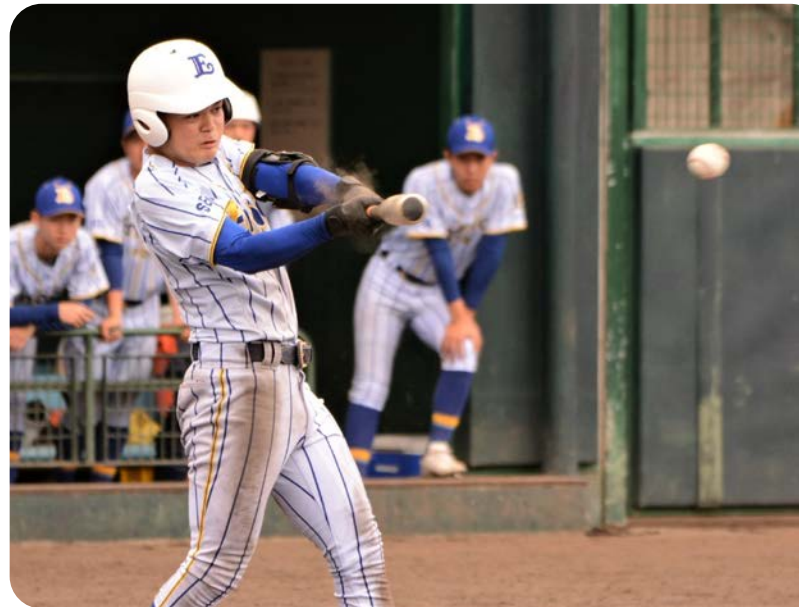

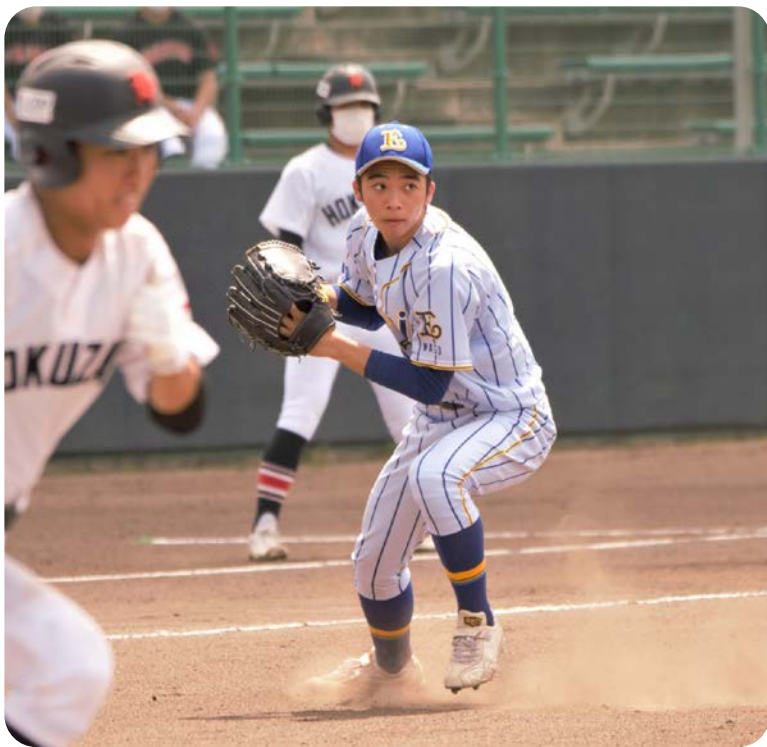


Enagic Sports High School Announces Baseball Team

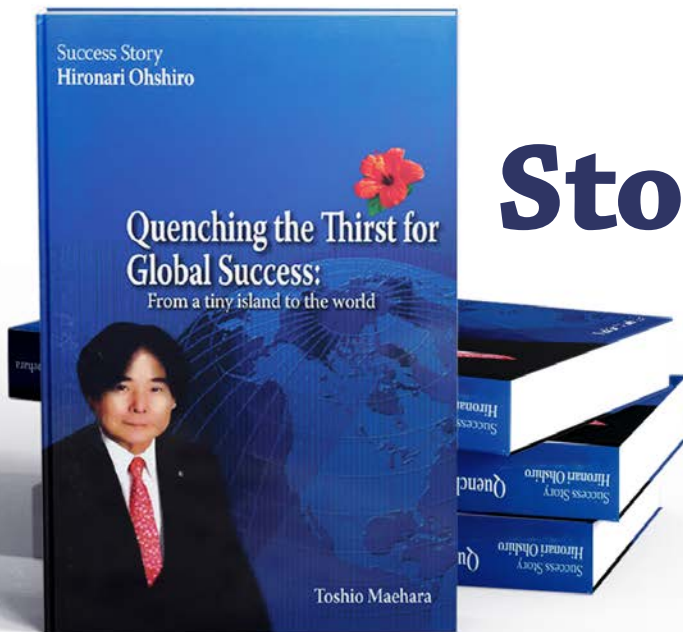
